By signing the Registration Form, the Participant also acknowledges that pursuant to Section 55(2) of Act CXXVII of 2007 on value added tax, Agrármarketing Centrum Np. Kft is entitled to issue the invoice for the participation fee prior to the Exhibition, which the Participant shall settle within the deadline indicated on the invoice, but otherwise latest by 15 July 2017. The invoice may include intermediated services. If the Participant fails to settle the invoice by the deadline, Agrármarketing Centrum Np. Kft shall be entitled to withdraw its offer. The Participant acknowledges that in the case of late payment of the participation fee, provided that the relevant legal conditions apply, he shall pay the default interest specified in Section 6:155(1) of the Civil Code and, pursuant to Section 6:155(2) of the Civil Code, starting from the date when he falls into default, an EUR 40 flat charge or the default interest specified in Section 6:48 of the Civil Code.

By signing the Registration Form, the Participant acknowledges that Agrármarketing Centrum Np. Kft will invoice any other costs arising in the course of the Exhibition (due to any subsequent requests of the Participant) within 15 days of the end of the Exhibition, and the Participant shall pay the amount of the invoice by transferring the funds to Agrármarketing Centrum Np. Kft's bank account indicated on the invoice within 30 days.

In the case of late payment of the other costs arising from the Exhibition, Agrármarketing Centrum Np. Kft shall, if the relevant legal conditions apply, claim the default interest specified in Section 6:155(1) of the Civil Code and, pursuant to Section 6:155(2) of the Civil Code, starting from the date when he falls into default, an EUR 40 flat charge or the default interest specified in 6:48 of the Civil Code.

**The Participant shall include the serial number of the invoice issued by Agrármarketing Centrum Np. Kft in the details section of the bank transfer order.**

The Parties shall make all efforts to resolve any disputes arising from this Registration Form in an amicable manner. If this proves unsuccessful, the Parties will be subject exclusively to the jurisdiction of the Buda Central District Court for their legal proceedings. For matters not included in this Registration Form, Agrármarketing Centrum Np. Kft's General Terms and Conditions relating to exhibitions and the applicable provisions of the Civil Code shall apply.
